Settlements

Attorney Stuart was able to negotiate a \$100,000 settlement for our client who was hit head on. Our client was in critical condition due to his multiple injuries including a broken hip, arms and leg.

Attorney Flora Templeton Stuart fought in court to receive a \$200,000 settlement for our client who was injured when a semi ran over his car. Our client sustained internal injuries, 4 fractured ribs, 2 types of brain injuries and a punctured lung.

Attorney Stuart was able to negotiate a \$157,000 settlement for our client who struck by a semi in his door. Our client sustained a broken shoulder, bruised kidneys, and punctured lung.

Social Security/SSI Disability

The Law Firm of Flora Templeton Stuart "puts the security back into Social Security Disability." Flora Templeton Stuart is a member of the National Organization of Social Security Claimants' Representatives.

Flora Templeton Stuart recognizes that people who have been injured or who suffer from physical or mental disability may be qualified to receive Social Security Disability and/or Supplemental Security Insurance benefits.

Who is Eligible for Disability Benefits?

Any disabled adult under the age of 65 is eligible for Disability Insurance Benefits, provided they have worked 5 out of the last 10 years. Children of disabled adults (who are drawing Disability Insurance Benefits), who prove to be disabled are eligible to draw Disability Insurance Benefits under their parent's record. Disabled widow or widowers between the ages of 50 and 60 may be eligible to draw benefits from their deceased spouse's Social Security record, if the spouse was eligible to draw Disability Insurance Benefits. A disabled person (including children) under the age of 65 who has not worked 5 out of the last 10 years can be eligible for Supplemental Security Income.

If you are eligible and receive Disability Insurance Benefits, then after you have been receiving these benefits for 24 months, you are eligible to receive a Medicare card, for a nominal amount, which will be withheld from your monthly benefits. If you are eligible and receive Supplemental Security Income and Disability you are eligible to receive a Medicaid card immediately after being approved for benefits.

How can I get Medical Documentation If I Cannot Afford a Physician?

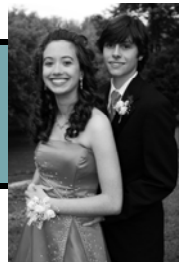
